#### **Late Entry Fees**

#### Forfeit of Fees

Fees will be forfeited if you do not attend or are absent from the exam and a satisfactory explanation is not provided to the Board.

#### Fees

The total fee for examination entry includes the examination fee of \$85.00, the sitting fee prescribed by your examination centre, and a late fee of \$85.00 if applicable. Contact your examination centre for their required sitting fee.
